



Alternative Approval Process (AAP)  
**Elector Response Form**

**UV Disinfection Facility and Pipelines Project**

**I am OPPOSED to the Black Mountain Irrigation District (BMID) proceeding with the formation of a bylaw to authorize the borrowing of \$7,000,000 for the construction of the BMID UV Disinfection Facility and Pipelines and related works.**

**Instructions:**

- If you **ARE NOT OPPOSED** to the borrowing of \$7,000,000 for the BMID UV Disinfection Facility and Pipelines Project, no action is required;
- If you **ARE OPPOSED** to the BMID borrowing \$7,000,000 for the UV Disinfection Facility and Pipelines Project, and you qualify as an Elector of the BMID, you may sign an *Elector Response Form*. To qualify as an Elector you **MUST** be a landowner within the BMID boundary. Proof of land ownership will be verified at the District office. If you are uncertain if you qualify, please review the requirements below.
- Exact copies of the blank alternative approval process *Elector Response Forms* may be reproduced.
- To sign an alternative approval process *Elector Response Form*, you **MUST** meet the following criteria for either a Resident Elector, OR a Non-resident (Property) Elector.

**Elector Qualifications** I, the undersigned, hereby certify that:

- I am eighteen (18) years of age or older;
- I am a Canadian citizen;
- I have been a resident of BC for six (6) months; and
- I am a **landowner** within BMID boundaries; or
- I am an **Authorized Agent\*\*** of any Board or Corporation that is an owner of such land or a legal representative of an owner of land in the Improvement District who has died, become insolvent, or insane;
- I am not disqualified by the *Local Government Act* or any other enactment or otherwise disqualified by law from voting in local elections; and
- I am entitled to sign this alternative approval process *Elector Response Form* and have not previously signed an *Elector Response Form* for the proposed project.

NOTE: In order to sign this *Elector Response Form* so it is valid, you **MUST** own property within the boundary of BMID and meet the above requirements. If you are still uncertain if you qualify, please contact the BMID office at (250) 765-5169.

- All *Elector Response Forms* must be received by the Black Mountain Irrigation District at the BMID Main office at 285 Gray Road, Kelowna, BC **on or before 4:00 pm on September 5, 2014** to be counted.
- Blank *Elector Response Forms* are available at the Black Mountain Irrigation District Office between 8:00 am and 4:00 pm weekdays, or on-line at [www.bmid.ca](http://www.bmid.ca) or at the informational Open Houses held at Black Mountain Golf Course, located at 575 Black Mountain Drive, on July 21 and July 28, 2014 from 3:00 – 8:00 pm.
- **NO** faxed or e-mailed forms will be accepted. Forms must have original signature(s), and can either be mailed to BMID attention of the Administrator at 285 Gray Road, Kelowna, BC, V1X 1W8 or dropped off at the BMID office located at the same address. Completed forms must be received by the deadline. Post office delays may render mailed submissions invalid if received after the deadline.
- **NOTE:** A person may not sign the Alternative Approval Process *Elector Response Form* more than once and may not withdraw his or her name from the Alternative Approval Process *Elector Response Form* after the deadline for submission of the petitions has passed. The requirements above must be met in order for this form to be considered valid. *Elector Response Forms* must have an original signature to be acceptable, must be via mail or delivered in person, and may not be submitted by email or facsimile.
- The number of Electors within the Black Mountain Irrigation District boundary is estimated to be 11,400. If ten (10%) percent (**1,140 Electors**) of the estimated number of Electors within the Black Mountain Irrigation District boundary signs an *Elector Response Form* in opposition to the proposed borrowing bylaw, BMID will not proceed to register a borrowing bylaw without then receiving the assent of the Electors by referendum.
- Personal information gathered on this form is collected under the authority of the Local Government Act and Freedom of Information Act and will be used only by the Legislative Services Branch to verify the validity of the petition.

\*\* **Authorized Agent** – A Letter from Corporation designating you as representative must be included.
